

Mass Deception: How Covert Extraterrestrial and Illuminati Influence are controlling world events.

Is there intelligent extraterrestrial life in the Galaxy? If so why have they not contacted us? Where are they located and what would they look like? Unfortunately the people most qualified to answer these questions such as biologists, physicists, philosophers, chemists, astronomers and religious intellectuals have always claimed that we are alone in the Universe. Historically they have always been incorrect because they have not had access to all the information that exists on the subject which is reserved only for a minority of privileged and very powerful people in the world. In this article we wish to demonstrate that reality is sometimes stranger than fiction and that the ruling elite of the most influential countries in the world have powerful motives for hiding the truth from the public.

The reality of the situation is that the laws of physics which govern the behaviour of matter and energy are calibrated to such a degree of perfection that it is inconceivable that they were not predetermined to create the conditions for life to appear in all its various forms throughout the universe. Intellectually and mathematically, the postulate that life exists only on Earth is both naive and absurd.

Recently biologists are beginning to realize that bacteria and viruses can exist in extreme environmental conditions ranging from hot water springs to Antarctic ice and only now are they beginning to suspect that these organisms may exist everywhere in the universe and may not necessarily require an oxygen environment to survive. After all, an entire ecosystem of organisms was discovered not so long ago which could survive kilometers below the sea in a Methane environment.

Contrary to the opinion of the scientific establishment, many intelligent extraterrestrial species share common physical attributes with Homo sapiens. In other words the biological model of bipedal locomotion with two counteracting limbs with fingers which vary in number from three to six, a torso with a head, two eyes, two ears, a nose and a mouth is a surprisingly common template in the universe. But why should this be the case? The answer has to do with geometry, symmetry and the capacity for a given species to manipulate its own environment.

Although Elephants, dolphins and Chimpanzees all possess the capability for sophisticated communication which is a precursor to technological evolutionary intelligence, they are all limited in terms of manipulating their environments because of two reasons. They either do not possess fingers to create tools and complex machines or they do not have sufficiently developed brains to solve abstract and complex problems in three dimensional space.

Some people may wonder why technologically advanced extraterrestrials would not have four sets of arms or legs like cattle and three eyes for example. The answer is that nature has a tendency towards efficiency and symmetry in evolutionary biological design and although some asymmetrically shaped creatures may sometimes make their brief appearance as a result of random genetic mutations, they invariably almost always become extinct because they are not efficient enough to survive intense competition for finite resources. This is why for example; no flying creature has ever been recorded living on Earth with an odd-number of wings which would be clumsy and not as efficient as symmetrically winged creatures like birds with two wings or dragonflies with four wings. It has to do with symmetry, balance, stability and agility in three dimensional space.

Possessing three eyes instead of two would not give its occupant a significant survival advantage because bi-focal vision requires only two eyes for a three-dimensional representation of our environment. Of course for spiders that possess eight sets of eyes, a 360 degree panoramic view of their environment is a significant survival advantage but this is a rare exception to most other developed forms of life on Earth.

Hence there is a geometrical and structural limit to variety in evolutionary biological design which is why the humanoid template is in fact one of the most efficient designs for the development of intelligent extraterrestrial species in the universe. In other words diversity has its limits and there are more similarities than differences in the universe. Having said this, there is nothing to stop a sufficiently technologically advanced species of extraterrestrials from developing unique physical attributes to enhance its naturally evolved body by genetically engineered methods.

But if intelligent extraterrestrial life exists, why don't they make their presence known? The simple answer is that they already have many times in our history both recorded and non-recorded but only relatively recently to the right people, those that matter. However, even if they hadn't made formal contact, they would probably adopt the same principle that we employ when we study animals in the wild. In other words they would be as discreet as possible with all the advanced technologies they had at their disposal.

In an analogous way that we use cameras equipped with long distance tele-photo lenses so as to not disturb animals in the wild who are unaware that they are being filmed, advanced extraterrestrial civilizations would study us from orbit with millimeter-resolution cameras. This is certainly plausible since the latest military surveillance satellites can read the title of a book from orbit. Others though would probably develop genetically engineered biological robots that look exactly like real insects or animals for example.

There is little doubt however that the majority of these extraterrestrial races would have technically advanced drones with artificial intelligence which would be totally silent and which could refract light to such a degree that they would be invisible to the naked eye. These living or non-living machines would no doubt have the capability to record the sound and vision of human activities. After all, why cause mass panic when you can study humanity in secret?

Also one has to remember that policy makers in the US Government experienced first hand how the public would react to a hypothetical extraterrestrial invasion in Orson Welles' realistic radio broadcast of "War of the worlds" in 1938 which caused widespread panic across America. Not wishing to repeat this outcome, policy makers who grew up in this period subsequently preferred to deny the truth rather than risk mass panic and economic disruption.

Moreover, why would any country reveal its top secret program of contact with an advanced extraterrestrial civilization if one of its most obvious objectives is to obtain technology to give it a tactical advantage over its potential enemies? This would make no sense particularly during the cold war.

Since June 2012 The SETI program monitoring deep space has purportedly detected three large spacecraft moving past Jupiter, apparently on their destination towards Earth. This follows the visit of three other ships, two of which supposedly landed in China and the third which landed somewhere beneath the sea off the coast of Indonesia last year. This information has perturbed many people. While we do not necessarily dispute the sightings of three unidentified spacecraft in the vicinity of Jupiter or that there are technologically advanced alien civilizations in our galaxy, we wish to explain the reasons why an open conflict scenario is most improbable.

Imagine that you are a technically advanced alien race and that you have had the technology to explore space for centuries if not millennia and your very powerful telescopes detect a probable oxygen-hydrogen atmosphere on Earth indicating the possibility of life on the planet. You send your robotic drones which confirm this fact many decades after the planet is discovered by your telescopes. By virtue of your advanced technology, your flying drones are optically invisible but also invisible to radar detection. You discover that the planet is populated by Homo sapiens, a primitive species of hominids who is at the pre-industrial level of development.

Not surprisingly you also discover that the planet is being monitored by other technologically advanced species of extraterrestrials and deduce from this that some of them have been observing humanity for a very long time and that they have almost certainly long established secret outposts or bases on the planet.

You soon determine that some of these subterranean bases are located under Mount Ziel in central Australia, inside Mount Perdido in the Pyrenées, Mount Hayes in Alaska, and Dulce, New Mexico, in the USA. Others though are located under oceans like the Adriatic Sea on the east coast of Italy while other bases are spread out across the solar system on the back side of the Moon and on Mars for example. For proof of past life on Mars type in YouTube "[UFO Disclosure - NASA accidentally Releases Evidence of Alien Life - August 13](#)" which reveals an artifact with a written language on it.

You also detect spacecraft in places where water and oxygen can be extracted like ice-rich Europa orbiting Jupiter and Rhea which orbits Saturn and has an oxygen-carbon dioxide atmosphere. Your observations over many years reveal that humans are generally primitive, potentially violent and are often predisposed to making war with their neighbours. As they continue their evolution, their scientific knowledge increases over the centuries until they reach an industrial level of development when something long predicted finally occurs. On the 16th July 1945 the first nuclear explosion is detected. You immediately increase the number of reconnaissance missions over major military installations in response and monitor intercontinental ballistic missile tests. Occasionally you destroy some of these missiles in mid flight and disable their electronic and electric firing systems in their silos to send a message.

But then something totally unexpected occurs which greatly accelerates the technical evolution of the species. A handful of accidents occur whereby extraterrestrial reconnaissance craft actually crash land on the surface of the planet due to unfavourable weather conditions in conjunction with human radar installations which interfere with the electronic navigation systems of the various spacecraft. Others though are shot down by ground-to-air missiles during the cold war. Humans suddenly gain unprecedented access to advanced technology. At first the technology on these various craft is so advanced it is baffling to humans and yet after years of persistent research and experimentation, the craft slowly begin to reveal their secrets. Within a relatively short period of time the richest parts of the planet undergo huge technological transformations as the ruling elite of these nations seek to make profits by secretly incorporating alien technologies into various consumer and industrial products. Semiconductor chips, lasers, optical fibers, night-vision binoculars and Kevlar amongst others make their unlikely appearance after the Second World War. The probability that the supposed inventor of the semiconductor transistor, Jack Kilby discovered the incredibly unique combination of elements and the complex doping processes involved to change silicon (*found in sand and quartz*) which is a natural insulator to a miraculous conductor of electricity is about the same as winning the Lotto. But because of national security concerns and cold-war paranoia, some of the greatest scientific breakthroughs are kept hidden from the public.

Your discovery alarms you to the point that action has to be taken. Your wisdom and experience in inter-planetary affairs has taught you that advanced technology in the form of weapons and spacecraft in the hands of intellectually primitive and spiritually devoid races is a recipe for disaster. It represents a danger to everyone including yourself.

Despite the fact you realize that a significant majority of ordinary humans have learnt to live peacefully and have no desire for violence and war in the 20th century, your observations reveal that the crime rates are nevertheless high. Even worse, you discover that the ruling elite of the most powerful nations are completely corrupt and have been exploiting the masses for millennia via secret societies, religions, large business, politics, international organizations, pre-planned wars and media disinformation on a planetary scale to achieve almost total economic and political control of the planet.

Some of these tainted organizations include The Council on Foreign relations, The Trilateral commission, The European Union, The OECD, The United Nations, Bilderberg, The Royal Institute of International Affairs, The World bank, The International Monetary Fund, The Bank for International Settlements, Interpol, Club of Rome, The Tavistock Institute, World Health Organization, UNESCO, NATO, The Knights of Malta, The Knights Templar, The Freemasons, The Thule society, The Nazi party, The Vatican, The Russell Trust, The Brotherhood of the dragon, The Order of the Rosae Crucis, The Black Nobility, The Qabalah and The Roshaniya amongst many others.

By the year 2012 there are only a handful of global ruling elite groups left on the planet which include combinations of royalty, rich industrialists, various mafia, senior defence personnel, powerful international bankers, intelligence agencies, prominent politicians, Police and Justice Departments, oil cartel members, food growing & production cartel members of the wealthiest nations. These loose coalitions are in direct competition with each other and have formed an uneasy alliance in the face of the extraterrestrial presence but also for reasons of self preservation. Another war would totally destroy the planet.

Fear of the extraterrestrial presence and paranoia reign among the ruling coalition so they decide to deploy advanced weapons in orbit in 1984 to defend Earth against a possible alien invasion. They include satellite-based as well as ground-based particle beam weapons located at places like Pine Gap and Nurrungar in Australia which are reverse-engineered from recovered alien spacecraft. These powerful beams of energy have a range of several thousand kilometers and can reach targets in orbit.

The program is hidden under the cover of “Starwars” known officially as the Strategic Defence Initiative which is described as an anti-ballistic nuclear missile shield in the media. For video type in YouTube *"NASA accidentally films UFO from Space Shuttle"* which shows a beam of energy aimed at a UFO in orbit that narrowly avoids it in 1991.

Despite this initiative the global power elite’s anxiety reaches a climax on the 2nd of December 1995 when the joint NASA/ESA SOHO solar satellite is launched and detects extraterrestrial spacecraft at impossibly close distances to the outer edge of the sun’s corona. Some of them are so large they defy human imagination, ranging from 200 kilometers in length to the size of large asteroids.

Other spacecraft are detected in the rings of Saturn with the Hubble space telescope presumably involved in some sort of mining operation. One of these craft is calculated to be 2000 kms long and another glowing and intelligently controlled spherical object is estimated to be almost the size of the moon! By the year 2012 it is estimated that no less than 70 technologically advanced extraterrestrial species are visiting Earth with or without the consent of the ruling elite. The vast majority of them are either benevolent or indifferent to humans, although a few species are classified as malevolent.

In 2007 a new defence project called HAARP part of which is located in Gakona, Alaska is finally completed. It is officially described in the media as an unclassified High Frequency Active Auroral Research Program. In reality it is funded by the US Air Force, US Navy and DARPA (*Defence Advanced Research Projects Agency*) who’s most prominent instrument is (*IRI*) 180 high-powered radio frequency transmitters operating in the variable frequency bands officially yielding a massive 3600 kW of (*ERP*) radiated power. Unofficially the power generators can yield five times that amount of power. HAARP also has VHF and UHF radars which can track extremely small objects in the Earth’s atmosphere.

It is one of a dozen or so similar installations located around the world in Australia, Japan, China, India, Russia, Ukraine, Peru, Brazil, Norway, Long island & Area 51 in the USA, Puerto Rico in Mexico and Antarctica. The transmitters are used to destabilize electronic navigation systems of extraterrestrial spacecraft entering the Earth’s atmosphere which are classified as hostile. HAARP can also be used for weather modification by concentrating electromagnetic energy in specific regions of the ionosphere. Your spiritual nature and natural aversion to violence restricts your options for action on the planet. Besides, your non-interference policy forbids you to act openly in the affairs of alien cultures even if Homo sapiens is genetically related to at least one of the extraterrestrial species monitoring Earth.

Known as the An-unna-ki (*Those who from Heaven to Earth came*) in Sumerian mythology and recorded in their cuneiform stone tablets or known as the Nordics, Tall whites or Pleiadeans today, this race of aliens lived on Earth approximately 200,000 years ago and some of their skeletons which look like giant versions of humans are periodically discovered by anthropologists and archeologists but they are quickly censored by the ruling elite of the scientific establishment.

According to Sergeant Major Robert O. Dean who worked at SHAPE (*Strategic Headquarters Allied Powers Europe*) in the mid 1960's with cosmic top secret clearance, this race is almost physically indistinguishable from ordinary humans with slight variations such as their pale, almost anemic skins and hair, unusually small and flat asian-type noses, slightly larger cone-shaped heads with larger brains, above average heights, athletic-type muscular bodies and telepathic abilities. A group of about 330 renegades who are philosophically opposed to the leadership on their planet have been on Earth for thousands of years, according to an Intelligence insider in the 1990's. Only a select few who are at the very top of the hierarchy in the NSA and who are initiated into the highest levels of Freemasonry such as the 33rd degree Lodge of Zion are aware of their existence. These anonymous power-brokers deal directly with all Extraterrestrial-related issues across the globe.

However you discover that another advanced species of extraterrestrials has no such qualms about interfering in human affairs. They are not so benevolent and wish to exploit the planet for its natural resources, in particular copper and gold which soon quadruples in price and other precious metals and minerals which are rare in the galaxy. These aliens known collectively as the Greys (*since there are many variations*) are also interested in collecting samples of plants and animals, including large samples of humans for genetic research purposes. Ironically this race of sentient beings is itself the product of genetic engineering by a far older and more advanced race of extraterrestrials that created them as a caste of workers long ago.

Apart from a few exceptions they have no reproductive organs, no lungs, no stomach and no intestines. Food in the form of liquids is absorbed directly through pores in the skin. According to Lieutenant Colonel Philip J. Corso who worked closely with General Arthur Trudeau, head of the US Army's Research and Development Department in 1961 in charge of the Roswell UFO, they appear to have been designed for long-term space travel by their creators and they are desperately trying to redesign themselves to eliminate genetic problems associated with repetitive cloning. To achieve their goals they use sophisticated mind-control technology and brain implants to infiltrate the ruling elite groups to control Government management of the planet thereby eliminating the risk of active military resistance to their presence on Earth.

To date their control is not absolute for reasons unknown. By the year 2012, you discover that the ruling elite have already planned a human population reduction program as far back as 1970 when **Dr. Henry Kissinger** was National Security Advisor in **President Richard Nixon's** administration. Representing the interests of Nelson Rockefeller and his associates at the Council on Foreign Relations, Kissinger pushed for the development of synthetic biological agents as alternatives to nuclear weapons. That year Congress approved a Department of Defence Appropriations request for \$10 million for the development of immune system ravaging viruses supposedly for germ warfare which was the perfect cover.

An aids-like virus called VISNA was subsequently discovered in sheep in Iceland and manipulated genetically to combine with human T-cells by **Dr. Robert Gallo** at Litton Bionetics and later at The Centers for Disease Control to produce AIDS and other variants such as N1H1, SARS, N7H9, BIRD FLU and NCoV amongst others. They also created cancer causing viruses and degenerative diseases like Parkinsons, Alzheimers, Fibromyalgia, Chronic fatigue syndrome etc. The ruling elite also introduced toxic chemicals in certain foods and liquids such as Fluoride (*one of the most toxic chemicals known to man*) in main water supplies and toothpaste which can cause sterility as a result of accumulated genetic errors in DNA over time.

You then discover that the global ruling elite have implemented a plan to censor all serious references to advanced theoretical physics and various clean-energy technologies in the public domain which have been discovered by humans either through their own efforts or leaked by whistleblowers and informants from the study of retrieved extraterrestrial spacecraft.

Independent inventors and engineers who try to bring their unique technologies to the public via mass-production are stopped from doing so. Serious articles containing new physics which could solve the world's energy problems are heavily censored or just taken off the web. Where they cannot be eliminated, computer viruses are created which make it impossible for the articles to be downloaded or copied.

Financial backing becomes unavailable and patents are simply bought outright by big business only to be filed away for eternity. Besides the ruling elite do not want any threat to the billions of dollars in income generated by the oil and gas industries.

In certain difficult cases, these people are discredited in the media or the intelligence agencies are simply instructed to make them disappear from the face of the planet. You also notice that a program to dumb down the masses has been implemented via the various media since the best way of eliminating a potential threat is to keep the masses both ignorant and poor.

To that end TV programs such as the daily news, newspapers and magazines are subjected to an ever increasing and sophisticated style of censorship. In fact the techniques employed are so sophisticated that the masses are totally unaware that they are being manipulated.

Serious qualitative documentaries on a wide variety of subjects are also quietly subverted or are no longer broadcasted altogether. Meanwhile the number of mentally-retarding programs on TV is increased to the general satisfaction of the masses. The editorial crews of most large international media companies are instructed to dumb-down the quality of virtually all informative programs to cater for the increasingly ignorant masses. The strategy works. Humans no longer have any idea of what is really going on behind the scenes in the world. They absorb and believe all the propaganda that is presented to them in the various media. They have no idea that 9/11 was an inside job, orchestrated by the CIA and Mossad for example and that Osama Bin Laden who was a former friend of the Bush family is not dead and is being kept as a prisoner somewhere in the world by the CIA.

Nor do they know that Pan Am flight 103 which exploded on the 21st Dec 1988 over Lockerbie, Scotland was organized by MI6 and the CIA and blamed on Colonel Muammar Gaddafi, the head of oil-rich Lybia as an excuse to expel him from power so that the World bank and the IMF, controlled by the Rothschilds, Rockefellers and 30 of the richest people in the world, could bankrupt the country and then plan for state assets to be sold to companies controlled by the global power elite for peanuts.

They also have no idea that Afghanistan was invaded to control the world's biggest plantations of poppy seeds used to make Heroin and Cocaine and that production has actually increased since the Americans invaded in 2001. They cannot imagine that the CIA controls the world trade in illicit drugs nor that Julian Assange, the founder of WikiLeaks was framed to silence him and that Lady Diana Spencer, Princess of Wales was murdered because she was beginning to support the Palestinian cause and was in a relationship with a Muslim, Dodi Al Fayed. There was also the possibility that she would reveal royal secrets which was confirmed by a former MI5 operative on YouTube.

They would never believe that President Barrack Obama's (*Barry Soetoro*) educational qualifications are grossly exaggerated and not a single student remembers him from Columbia University. In fact the man was not even born in the United States and is actually a pawn who was chosen to represent the interests of the international bankers.

They would also never believe that the CIA is actively trying to disarm the American public which represents the single biggest threat to a fascist US Government before it declares martial law when the country is finally declared bankrupt.

The only way they can justify the banning of guns is by organizing the murders of children to gain the public's sympathy and approval by heavily drugged or unstable individuals who have undergone serious psychological mind-control programs.

The second strategy to dissuade potential dissent from humans involves the active degradation of educational institutions and the quality of their courses. Tuition fees are also introduced to make students poorer. The financial budgets for schools and universities are systematically lowered and their curriculums are seriously modified. Standards are lowered everywhere.

To make the masses poorer, several strategies are introduced. Firstly, the dozen or so secretive and privately-owned large international food groups which control the vast majority of the world's food production collude on price which is not a problem since the judiciary systems of most countries have also been infiltrated. A quote from James Randall, former CEO of Archer Daniel Midlands which is the largest food processing-agribusiness in the world reveals the mentality of the elite, "Our competitors are our friends. Our customers are the enemy."

The price of food is fixed and increases steadily as standards of living drop around the industrialized world. Small independent producers of quality foods are squeezed out of the marketplace by predatory pricing practices and replaced by similar but inferior quality products at a higher price. Consumer choice begins to reduce at an alarming rate although the public doesn't notice the deception due to clever branding and marketing differentiation in supermarkets of identical products from the same suppliers.

Secondly the prices of gas, petrol, electricity and water are dramatically increased while minor tax breaks are made to placate the masses. The price of high-consumption products like alcohol and cigarettes are constantly increased while new taxes like the Carbon tax are introduced.

Thirdly an unsustainable level of immigration is introduced from the poorer countries to the richer countries as an effective means to create a shortage of real estate while the sale of Government land is severely restricted to increase the price of houses, apartments and land. Also controlling multi-cultural countries like the USA is easier than mono-cultural countries like Japan or Iceland who's citizens think in a similar way.

Fourthly the notion of acceptable debt is introduced via free credit cards, bank cards and a multitude of other credit products from consumer and financial companies. Casinos are legalized and other forms of gambling multiplied, indeed they are encouraged and become socially acceptable. The strategy works. Bank savings are dramatically reduced and many people become addicted to the debt trap.

Fifthly, investment in the stock market is encouraged while periodic stock market crashes are organized in conjunction with exorbitant interest rates set by the central banks of many countries such as the USA, Australia and the UK which are secretly owned by large private international banks. The strategy works. Many people struggle to repay their mortgages during these times while others lose their life savings.

Finally, industrial production is relocated from the rich countries to the poorer countries which creates massive unemployment in the rich countries but which also has the effect of lowering real wages in these countries. The strategy works. The middle class is significantly reduced while the number of people living in poverty increases accordingly.

Meanwhile the wealth of the richest nations is conveniently concentrated into the ever fewer hands of rich industrialists, international bankers, organized criminals and politicians who are now virtually all under the control of the malevolent aliens.

You then notice that a surveillance strategy has been implemented to keep abreast of human activities at the individual level. Large computer databases for the purposes of population control located at places like the Deakin Exchange which is a joint ASIO & NSA facility in Canberra masquerading as a Telstra Billing centre keep incredibly detailed records of every citizen's activities from their salaries to their spending habits. These databases are linked to an international network of other databases utilized by the military and intelligence communities. Satellites (*PRISM, ECHELON*) that spy on mobile phone relay antennas even track individuals who have been injected with nano-thermionic bio-chips that convert heat to electricity. Cameras are installed in every city to monitor human activities. The cameras on every laptop and computer are used to spy on selected humans who are potentially troublesome. Their computer activities are logged on a daily basis and their files can be accessed anytime and anywhere when they are on the web without the knowledge of their owners despite firewalls and anti-virus software because of secret National Security Agency encryption keys incorporated into every Windows Operating Systems ever sold on the planet.

Moreover the latest mobile phones have spyware incorporated into them and can be used to relay electronic pulses to the brain or the body to influence behaviour. Particularly troublesome individuals can be targeted by microwave devices which disrupt the specific frequency of the individual's brainwaves. The visual cortex of the brain is instantly affected which causes the target's field of vision to spin uncontrollably. Disorientation, nausea and headaches soon follow. The following quote by **George Herbert Walker Bush snr, (*Illuminati member*)** former CIA chief & President confirms this in a remark to Sarah Newcomb McLendon, white House reporter in June 1992, "If people find out what we've done, they'll chase us down the street and lynch us."

These weapons are either land-based or airborne on reverse-engineered human spacecraft which have the capability to become optically invisible. An object can only be seen if it reflects light back to one's eyes. If it doesn't, then it becomes optically invisible. In fact professional magicians have been using the same principle for many years now. A wonderful example of this is David Copperfield's YouTube video in which he demonstrates partial invisibility using plastic prisms which refract the light around his body.

The world's best scientific minds with billion-dollar black-project budgets have successfully reproduced "skins" covered with a refractive nano-scale material recovered from the exterior of extraterrestrial craft which absorbs all wavelengths of light, bends it and redirects it in a desired direction.

There are only two ways of detecting these craft, one is with very sensitive infra-red or chemical-imaging cameras and the other is when they are located in weather conditions such as clouds, mist or fog which reveal the silhouette of the circular disks.

The propulsion systems of these classified craft are based on the rapid rotation of a liquid metal similar to Mercury for example, which becomes "superfluid" at extremely low temperatures in a superconducting toroidal chamber under extreme pressure. This has the overall effect of cancelling gravity.

These craft are capable of stationary levitation and of velocities well beyond the capabilities of conventional fighter aircraft in the vicinity of Mach 25 to 35. Aerodynamic experts would contend that this is impossible because air friction at Mach 3 causes overheating to the point that metals like Titanium have to be used on conventional aircraft airframes. They have no idea that the powerful magnetic fields of these craft accelerate the ionized air molecules around their hulls at approximately 1/5 of the velocity of light thereby creating a vacuum around them which eliminates friction and maintains relatively low hull temperatures.

Witnesses like Captain Bill Uhouse, an ex Marine Corps fighter pilot who spent four years testing exotic experimental aircraft and flying disks at Wright-Patterson Air Force base and who later worked as an engineer for Defence Contractors developing anti-gravity propulsion systems would gladly contradict them.

So would Dan Morris, a retired career Air Force master Sergeant who was recruited in the super secret National Reconnaissance Office with a **cosmic top secret** clearance (*38 levels above top secret which no US president has ever had*) where he worked on extraterrestrial-connected projects.

This type of propulsion system is a more sophisticated version of the “Biefeld-Brown effect” which the Nazis used in their experimental flying saucers of the late 1930’s which were subsequently captured and perfected by the Americans and Russians after the Second World War. The **Biefeld-Brown effect** was then censored and eventually forgotten by mainstream science until amateurs working for Transdimensional Technologies of the US and J. Naudin Labs of France rediscovered the effect in the late 1980’s with their so-called “lifters” which could levitate with electricity.

Then in 1992 at the University of Tampere in Finland, a Russian physicist named **Yevgeny Podkletnov** confirmed the levitation effect quite by accident strongly suggesting that the physics of antigravity was a real possibility.

However the power elite of the international scientific community quickly discredited his work in the media and the press to silence him and to make him appear to be incompetent. He was dismissed from the university soon afterwards.

In 1993 Profs. **N. Li** and **D.G. Torr**, two American scientists who were working on the gravitational shielding effects of rotating superconducting disks in high frequency electromagnetic fields at NASA’s Jet Propulsion Labs obtained limited but positive results confirming Podkletnov’s work. Not long afterwards they both disappeared from the face of the planet never to be seen or heard of again.

Finally in 2005 a theoretical basis for antigravity was discovered by an unknown and solitary physicist working in Paris, France. He discovered an equation which unifies Quantum Mechanics with General Relativity but it was quickly censored and taken out of circulation before the article was published in serious peer-reviewed scientific journals. All copies and references to the article on the internet were also eliminated.

The equation has two solutions for Quantum Gravitational Energy and is very similar in structure to the equation for Gravitational Power in General Relativity:

It differs only from General Relativity in that the frequency of the gravitational waves is not synchronized with the frequency of the angular velocity of the rotating mass. This is because the waves travel at the velocity of light whereas the maximum tangential velocity of a given rotating mass is considerably slower. The frequency of the waves is therefore proportional to the frequency of angular velocity but not identical as it is in GR.

The article asserts that since Dirac's relativistic wave equation also has two solutions for energy, one for matter and one for anti-matter, that matter therefore produces gravitational waves whereas anti-matter produces anti-gravitational waves which completes the symmetry.

The first remarkable conclusion from this work is that electrical current is not what has traditionally been defined in physics textbooks as “the rate at which moving electric charge crosses a given surface area” since the mean drift speeds of electrons and ions in typical metal conductors is on the order of a couple of millimeters per second.

Rather it is the successive absorption and emission of photons by individual electrons which constitute the electromagnetic waves which are transmitted at relativistic speed across the electrons. The article infers that electromagnetic waves in conductors are more powerful than their counterparts in vacuum because their energy levels are augmented by the electrons which in reality are nothing more than microscopic black holes.

This is corroborated by the fact that the “fine structure constant” $\alpha \approx 1/137$ is equal to the mass to radius ratio between an electron and Plank’s black hole:



















Above. A gigantic rectangular spacecraft.




Above. A gigantic rectangular spacecraft.

















Lower case letters indicate **weaker alternate agreement** by at least two persons or a slightly favored interpretation by two persons (with no clear stronger consensus).

Numbers in parentheses represent the lines of the message. By early convention, the first clearly present line in the message was numbered line (1). However, another line of text exists in shadow and sharply tilted away from the camera above line (1). To maintain early convention, it has been called line (0). Only one person has attempted to read it (Rudiak) and there is no basis for comparison.

There are about 65-71 visible words (depending on reader) from lines 1 to 9 consisting of about 320 read characters (excluding spaces). There is currently plurality to unanimous consensus on about 76% of the words/letters and strong consensus to unanimous agreement on about 41% of the words/letters (at least 2/3rds of readers agree), with 48% consensus on majority to unanimous reads (at least 5 readers agree). I (Rudiak) currently agree with 99% of the overall stronger consensus word/letter reads (50% or more of readers), but drop to about 75% overall agreement when weaker consensus words/letters are added. I have strong disagreements with consensus where I consider letter counts to be wrong ([see graphic & discussion](#)), grammar poor, and/or poor semantics or sensibility in group reads.

About 40%-50% of the words (depending on reader) are very common English "framework", short words, such as "the", "of", "at", "to" "and", "you", "for", etc. Many of these are relatively easy to pick out and help define the grammatical structure. E.g., the word "the" (most common English word) is likely to be followed by a noun, particularly in a telegram where adjectives tend to be few. (Examples: "the victims of the wreck", "the 'disc'"). "Of" (second most common English word) is likewise probably going to be followed by an article like "the" or a noun or adjective. (Examples: "of the wreck", "meaning of story", "of weather balloons")

In cases where the interpreter mixes capital and lower case letters (Rudiak, Morris, Fishbine, McNeff), capital letters show a higher level of confidence in a letter or word (convention introduced by Morris); lower case letters indicate a lower level of confidence and are generally best guesses or filled in from context. Letters or words in parentheses are concealed and best guesses. Question marks either represent invisible letters with no best guess or disagreements in number of letters between interpreters. In some cases, alternative words for a reading are also indicated under the preferred, best-guess words and placed in brackets.

The top line of x's represents letter and word counts suggested by Rudiak. The x's represent characters that are definitely or probably there as determined by inspection, letter spacing, and/or column alignment with characters directly above or below. Indicated spaces are also

definitely or very likely there. Indefinite characters (there could be a character or space there) are indicated by the hyphen '-'. Extra spaces between words have sometimes been inserted to maintain alignment between different interpretations. These extra "padding" spaces are indicated by the underscore '_'.

Please see [graphic showing columns of characters lined up](#) so that letter counts can be easily and objectively determined. This is why I dispute various other reader letter counts and words. The main disputes involve words dipping into the center crease. **Word reads of others I deem definitely wrong because of obviously bad counts I have underlined.** In most cases, readers have done a good job of sticking to proper word lengths. One however (McNeff, or MN), has deliberately misspelled three words containing double letters in order to make his words fit, using the dubious assumption that Ramey typed his own memo and was a bad speller. I have underlined these misspellings as well.

It is not always apparent in different presented reads by individual readers exactly what words/letters correspond to what in a line. Words/letters are therefore lined up on the basis of best-guess matching lengths and similarity of lettering to others.



















The authenticity of the Apollo 11 UFO sightings on the moon has been confirmed by legendary US CBS TV news anchorman **Walter Cronkite**. In an interview with the *National Enquirer*, conducted by reporter Robin Leach, Cronkite gives the following testimony: “En route for the world’s first moon landing, Armstrong and the crew transmitted some earthshaking information and I was there to hear it for myself.” Cronkite further stated: “Armstrong claimed to have spotted a huge cylindrical object which was rotating or tumbling between the ship (*lunar module*) and the moon. It’s officially recorded in the NASA record vaults that Armstrong indicated he went to take photographs but the object vanished as quickly as he’d first seen it. Neil Armstrong is not a man given to fanciful imagination and it wasn’t just one of the crew who saw it... they all did and you have to respect those men.”

Maurice Chatelain, former NASA chief of communications, referring to the Apollo 11 mission: “...when they made the first moon landing on the Sea of Tranquility and only moments before Armstrong stepped down the ladder to set foot on the moon, two UFO’s hovered overhead. Edwin Aldrin took several photos of them...”

Eugene Cernan, Commander of Apollo 17 mission, “...I’ve been asked about UFO’s and I’ve said publicly I thought they were somebody else, some other civilization.”

Astronaut Dr. Brian O’leary, “..we have contact with alien cultures.”

Charles J. Camarda, NASA Astronaut Ph.D. “In my official status, I cannot comment on ET contact. However personally, I can assure you, we are not alone!”

Colonel L. Gordon Cooper (Mercury 9, Gemini 5 Astronaut) “I believe that these extraterrestrial vehicles and their crews are visiting this planet from other planets which obviously are a little more technically advanced than we are here on Earth.”

Captain Edgar Mitchell, Apollo 14 Astronaut “..we all know that UFO’s are real. All we need to ask is where do they come from and what do they want?”

Dr. Storey Musgrave, NASA scientist and Astronaut “I believe and I am scientifically certain that there are endless other living forms out there, including intelligent sentient beings”.

Scott Carpenter, Astronaut Johnson Space Center “At no time when the astronauts were in space were they alone. There was a constant surveillance by UFO’s”.

Christopher Kraft, NASA Base Director Houston confirmed that Apollo 11 was intercepted on the moon by UFO's after he retired. Armstrong & Aldrin: *"Yes..they're in the right place...but whoever made those spaceships surely can come tomorrow and remove them...over and out."*











According to the Farsight Institute, the original discovery of the active industrial site and giant nozzle spray was made by Patrick Skipper, a Mars anomaly researcher from photos taken by NASA's Jet Propulsion Laboratories. Dr. Brown presented the results of the Mars remote viewing (*clairvoyance*) study at a presentation in Montreal, Canada on the 6th July, 2010. Tentative results of the study, based on high clarity scores of the remote viewing sessions included the following:

- 1) A large dome at the site is an artificial structure.
- 2) Tunnels connect various chambers at the site.
- 3) The original builders of the site were ancient.
- 4) The current occupants of the site do not understand its original technology.
- 5) The level of the original technology is high.
- 6) There is a shortage of spare parts at the site.
- 7) The site may be used for power or energy generation.
- 9) There are intense flashing lights at the site.
- 10) There is a sense of despondency among the occupants of the site.
- 11) There is a laboratory setting at the site, occupants wear uniforms and there are more men than women.
- 12) The site occupants view this location as a hardship post.
- 13) The site occupants cannot return home and knew that when they accepted the assignment.
- 14) There is no ET content. The remote viewing does not affirm an extraterrestrial presence at the site.
- 15) The occupants of the site could be human.
- 16) The occupants of the site are of unknown origin.
- 17) The site may be a black budget operation.
- 18) The remote viewing interpretations of the site may be a decoding error.

Professionally trained remote viewers employed by the US military or intelligence agencies typically have a 60% to 70% accuracy rate depending on the target location. The remote viewing programs are used as intelligence gathering information which is classified as speculative until it is corroborated from other sources of information such as direct witness accounts or various types of photographic evidence. The study concluded that there was a high degree of correlation between obvious target characteristics as determined by the target image and the detailed remote-viewing data. "In the aggregate, this study offers strong support for the idea that the spray and two dome formations deviate from known geological processes and thus may be artificial."

However, it must be noted that the visual interpretation of the photo by Patrick Skipper may be incorrect and this may have influenced the remote viewers in some way.




Above. Probable human spacecraft (*possibly the TAW-50 or Nautilus*)

The TAW-50, the Aurora and the Nautilus are all space faring vehicles which employ standard anti-gravity weight reduction technology as well as magnetic pulsing propulsion technology. Their maximum speeds range from 35,000 kms/hr to 61,000 kms/hr for the TAW-50 and they can come to a complete stop in virtual seconds and reverse direction almost instantaneously with hardly any noticeable loss of speed or adverse G-force effects on the crew because inertia is nullified within the crafts. In short, they have similar aerial performance characteristics as extraterrestrial spacecraft. To observe actual film footage at night, type *“UFO over Jerusalem dome of the rock Israel”* in YouTube or google search which depicts a drone with similar characteristics.

According to Richard Boylan Ph.D. Emeritus professor of Psychology and specialist in this area of research, the Aurora can travel to the moon and back while the Nautilus makes twice a week trips to a secret military intelligence space station which has been in deep space for the last 30 years. NASA’s official space program is therefore a cover for the real and classified space program which is an international undertaking. This is why NASA’s budget has been steadily cut back over the years. Why build expensive and obsolete Saturn rockets when you have the technology to fly into space at a fraction of the cost?

The secret international space program has been active for more than 30 years. This has been corroborated by **Gary McKinnon**, a Scottish computer hacker. Between February 2001 and March 2002, Mckinnon hacked into dozens of classified US Defence and NASA computer mainframes and networks where he saw pictures of Alien spacecraft and files which made references to “non-terrestrial officers” and names of ships which are not recorded in the US Navy or anywhere else for that matter.




Above. Unidentified spacecraft in high Earth orbit.



HAARP FACILITY IN GAKONA, ALASKA




HAARP (EISCAT) EFFECT IN RAMFJORD, NORWAY



CENSORSHIP ON THE INTERNET

Aluminium is never found in its metallic form in nature and occurs as bauxite, a mixture of Aluminium oxides, Iron oxides and clay and since it is difficult to isolate it was only discovered in 1807 and produced as a pure metal by Danish physicist Hans Christian Oersted in 1825. It wasn't produced in commercial quantities until 1886. Russian scientists concluded that either this tooth is of extraterrestrial origin or that it belonged to a previous technological civilization (*possibly reptilian*) which evolved on Earth some 250 to 300 million years ago.

Dinosaurs first appeared during the Triassic period 231.4 million years ago and were the dominant terrestrial vertebrates for 135 million years, from the beginning of the Jurassic period approximately 201 million years ago to the end of the Cretaceous period when a mass extinction occurred approximately 66 million years ago.

This was due in part to the impact of a massive asteroid which contributed to climate change and ecological changes in the environment but also because of the emergence of mammals to name a few reasons. It has been speculated that despite the Cretaceous-Paleogene extinction event which in theory wiped out 3/4 of dinosaur species, some of the more intelligent Saurian theropods who may have evolved human-level types of intelligence by this time could have survived. They certainly had enough time to evolve, in fact considerably more than *Homo sapiens*. If this was indeed the case then *Eoraptor* could have been a possible candidate for a technologically viable species of reptiles indicated **Below right** :



Of course this is pure speculation however it may be a possibility since many reptiles such as snakes, turtles, crocodiles, lizards and birds all managed to survive to this day. If *Eoraptor* did indeed survive, then its technological capabilities today would be literally "god-like", in other words so advanced as to be beyond our comprehension.




EARTH-BASED OR NATIVE REPTILIAN BEINGS

If Earth-based reptilians exist, they would almost certainly live in subterranean bases beyond the detection of our most advanced instruments and they would probably regard humans in much the same way we consider a herd of cattle for example. According to the **Lacerta Files** which is an unconfirmed but convincing Swedish interview with a reptilian sociologist or behavioural scientist, human paleontologists have never been able to find bones of intelligent reptilians because they have lived deep underground in giant cavern systems since the cataclysm 66 million years ago.


It also mentioned that one of their bases was located near a lake in southern Sweden. On the 19th July, 1946 a cylindrical ship crashed into Lake Kölmjärv. Irrespective of where reptilians originate as a species, it does not change the status quo, ie: humans would still be unwittingly subservient to them or manipulated by them in some way. According to **Thomas Edwin Costello** who was employed by the **Rand Corporation** (Ref. *The Dulce Papers*) & (video in YouTube "[Secret underground base officer speaks out](#)"), the green-skinned reptilians are native to Earth while other species like the brown and white skinned reptilians are from Draco, a 14 star system all with planets located in the Orion constellation spread between 12 to 32 light years from Earth.

They would also certainly have the genetic skills to create life forms to their specifications like for example, a Grey species of extraterrestrial clones to perform specific tasks whenever and wherever they wanted in the galaxy. Of course every now and then a part of the herd on Earth would have to be culled to provide specimens for food, scientific study and experimentation, to maintain reasonable numbers for control purposes and to protect the environment. This would be achieved obliquely through the intermediaries of the Greys with or without the cooperation of the Illuminati.

It must be noted however that every extraterrestrial species present on Earth or in near Earth space has its own agenda and the geo-political situation between these various species and the Illuminati is certainly bound to be complex. One cannot simply place all the members of a given species into a particular moral category, ie: good or evil. There are no doubts alliances between and within species who's behaviour probably places them on opposing sides of human moral standards.

Then there are extraterrestrial species who are just passing through our solar system and are politically and morally indifferent to humans. They are probably just curious enough to study us but not enough to establish a permanent presence on Earth.

In conclusion, we have made a solid case for the reality of the Roswell case and therefore, by logical deduction, other species of extraterrestrials must exist. It has been estimated by intelligence analysts that the Greys are at least 3000 years ahead of contemporary human science in technology and they have "complete mastery over matter". However this is misleading since the global elite's reverse-engineered alien technology obtained from crashed UFO's and trade agreements with the Greys as well as advanced technology developed by geniuses which has been classified TOP SECRET, is in some instances up to 1000 years ahead of contemporary science.

Nevertheless it is known for example that both the Reptilians and the Greys possess technology that allow them to literally pass through solid matter like a human hand passes through water, irrespective of the material in question whether it be steel, wood or plastic for example. This is possibly done by a process which involves powerful electromagnetic fields calibrated at the precise frequencies of the nucleonic field which bind protons and neutrons in atoms ie: (*strong nuclear force*) of the material in question. Corroborating evidence comes from experiments conducted by **John Hutchison** with powerful electromagnetic fields which caused various objects to levitate but also melted or ripped apart thick and large pieces of metal which could not have occurred unless they were in a steel mill furnace for example.

How can electromagnetic fields disrupt strong nuclear bonds? The answer requires new concepts in physics but according to the Lacerta files and the testimony of a claimed but unproven reptilian behavioural scientist, the four known forces are really just different manifestations of a single unified force at different frequencies. Corroborating evidence comes from the new Quantum Gravitational equation which suggests that Gravitation is a purely geometric effect of an otherwise quantum electromagnetic effect.

It is also known that the reptilians employ advanced holographic technology which they use to impersonate or circulate amongst humans. Some people refer to this as "shapeshifting" which is not a very accurate description of the phenomenon. The holograms of human faces and heads conceal reptilians' or (*other unknown aliens*) real appearance beneath the holograms. This is not science fiction but fact.

STRANGE SOUNDS HEARD ALL OVER THE WORLD

Many strange and apocalyptic sounds emanating from the sky have been heard all over the world in 2012 and 2013. Many ridiculous theories have been put forth to explain these sounds. We wish to put the record straight once and for all. The sounds emanate from spacecraft which are cloaked or invisible. Whether these spacecraft are human or extraterrestrial remains unknown.

The purpose is to test the reaction of people to the sounds. Why? This is unknown, however one can speculate that it would probably involve the manipulation of the masses in some way.

WHAT IS TIME?

Although Einstein and many others before him such as Poincaré and Lorentz for example, understood the relativity of time, nobody since has explained in a practical sense, the true nature of time and its application to all things living and non-living in our universe. Moreover the situation has been exacerbated by varying and incorrect interpretations of "time" within the context of Special Relativity to the point it has become obvious that many professional physicists and UFO researchers alike actually have a limited capacity for understanding Einstein's work. To solve these problems we present the following definition of time which is immutable:

“Time is nothing more than an arbitrary and relative measure of the change in the physical state or set of coordinates of a given object to another physical state or set of coordinates in three dimensional space”.

An object can be anything that exists within the realm of matter, anti-matter and energy no matter how small or large. By “change in the physical state of an object” we imply a change in the physical properties of this object (*atomic, chemical, electrical conductance etc*) or its total mass content including its potential energy. A change in the set of coordinates of a given object relates to its location in 3-D space which includes its total kinetic energy.

Since change is a universal constant, anything that experiences change, no matter how slowly or imperceptibly such as a tree growing to maturity or quickly like the velocity of a photon on a ray of sunshine necessarily adheres to this definition of time. This universal law applies to all types of matter and anti-matter and for this reason alone; one cannot talk about the arrow of time or a single homogenous “time” in the universe.

On the contrary, there are an infinite number of “times” in the universe; in fact as many as there are objects in the universe. Therefore once this change has occurred, it is absolutely impossible to revert back to where the object in question was located at a different set of coordinates or to when it was in its former physical state. This is because of the universal law of entropy. To go back in time would require an infinite amount of energy because the universe is infinite and contains, by definition, an infinite number of objects.

The situation is actually vastly more complex than most people realize. Consider the process of nuclear fusion in a given star such as our sun for example. The passage of time will vary from one spatial coordinate relative to another coordinate within the star depending on the kinetic energy of an atom of Hydrogen for example relative to another atom of Hydrogen which has either more or less kinetic energy. This will also depend on the potential energy of the magnetic field influencing this particular atom of Hydrogen relative to the influence of the field at another spatial coordinate on the second atom of Hydrogen.

Hence it becomes obvious that there are billions of atomic and sub-atomic particles experiencing different “times” within the sun at any given moment during the conventional interpretation of "human time".

To complicate matters further, the notion of distance in this definition of time is not as straight forward as one might think. Most physicists are familiar with relativistic length contraction when objects approach the velocity of light. What they are not familiar with is the relativistic effect of scale on distance or length within the context of fractal geometry. Consider the coastal distance from Melbourne to Sydney as an example.

How long would it take for light to travel this distance? We know that the distance for motorists is approximately 850 kms in a relatively straight line so a quick estimate might give us twice this distance, say around 1700 kms.

So the time for light to travel this distance would be:

$$1,700,000 \text{ m} \div 299,792,458 \text{ m/s} = 0.00567 \text{ s.}$$

Well actually this is deceptive because if we could hypothetically lower the scale of measurement of the coastline to the centimeter to increase the accuracy, we would find that the distance between Melbourne and Sydney has increased by a factor exceeding one billion and it would therefore take several hours, if not days for light to travel this distance. If we then increased this accuracy down to the atomic scale we would find that the distance is almost infinite by which time it would take an eternity for light to travel along this coastline. So in this particular context, the notion of time as a relative change from one set of coordinates to another set of coordinates also depends on the **relativity of scale**. It therefore becomes obvious that the notion of the passage of time at our level of perception (*the macrocosm*) is almost certainly different to that of the passage of time experienced from the perspective of the world of the microcosm for example.

Another relevant question to be raised in this context is; when does a future event become a past event? We want to make it absolutely clear from the outset that the notion of the “present” is an illusion and does not actually exist contrary to popular opinion. To prove this consider a mantel clock with the hour, minutes and seconds hands’ indicating it is exactly midnight whereupon the bell rings. At that precise moment and assuming perfect accuracy, are we in the future, present or the past? The answer of course is that once an event has occurred, which in this case is the ringing of the bell; it belongs by definition, instantaneously to the past.

Before the event occurs, then it is still part of the future. But how do we know that it is exactly midnight when the bell rings?

The answer is that in reality the accuracy of this mechanical device is limited by its physical design so we cannot be absolutely certain that it is exactly midnight when the bell rings. There are other clocks which can measure time more accurately of course, but as a general rule, whenever we divide standard time into extremely small portions to measure the passage of an event then we introduce inherent inaccuracies in the measurement process known as Heisenberg's uncertainty principles. **Heisenberg** discovered two of these principles which state that the more accurately one measures one variable the less accurately one can determine the other.

Energy and time comprise one pair of variables while momentum and position make up the other pair. This means that there is a limit to the amount of information one can obtain from a given quantum system and trying to determine whether an event is in the future or in the past becomes blurred when the product of these two pairs of variables approaches Planck's constant. This constant represented by the letter h , is present everywhere in physics because it is a fundamental description of reality, particularly that which pertains to the incredibly small, in other words the microcosm.

Let's consider a more complex example of time now such as thousands of raindrops falling in the proximity of a single person. As they fall down through the sky, are the individual raindrops in the present, past or future relative to the observer? The answer depends on what is defined as the **decisive event**? If it is raindrops breaching the altitude of 1000 m before hitting the ground then any raindrops above this altitude will represent future events and any raindrops below this altitude will represent past events. The problem is that the information at that altitude is inaccessible relative to an observer located on the ground. Can he prove that this imaginary line in the sky is actually there at any given moment in conventional time? Not by himself and not without the help of technology. This implies that the availability of the information pertaining to a decisive event or set of events is often limited to the perceptual awareness of an observer.

Since the event of raining is more or less a continuous process while it lasts and it comprises a large number of individual raindrops at any given moment in conventional time, some raindrops will therefore be in the future as they fall and others will be in the past relative to the person's ability to perceive the rainfall by touch, sight or sound. In practice this will be limited to a few dozen meters at most. In this context one can begin to understand that in certain circumstances whether or not an event is in the future or the past depends not only on the location of the observer relative to the event but also on the observer's perceptual awareness of the event and his ability to measure it. In other words his ability to obtain information about the event in question.

So, the answer to the old proverb, “Is the moon there if you don’t look at it” is more complex than previously thought. The notion of reality or the degree of reality of an event occurring really depends on the amount and quality of information an observer can obtain from this particular event.

As a general rule, information is more readily available from the macroscopic scale than from the microscopic scale. For example, even if one does not look at the moon, we still perceive it to be real because there is convincing evidence or information available to prove its existence. There is visual confirmation from telescopes and mirrors located on the surface of the moon which actually reflect laser light back to earth which allow astronomers to calculate the earth-moon distance with great accuracy for example. There are also tides caused by the moon’s gravitation which provides further evidence for its existence.

However the availability of information pertaining to the quantum entanglement of two photons which obey Heisenberg’s uncertainty principle is severely restricted relative to say, an observer located at the macroscopic scale for example so this event’s relative degree of reality is therefore correspondingly lower.

But what happens when an event is either extremely rapid or incredibly slow? Consider a bolt of lightning flashing and spreading across a cloud. If we were to film this event with a high speed camera we would find that once the first part of the flash has occurred it will belong to the past but the part of the lightning that still hasn’t spread across the cloud will belong to the future because it hasn’t occurred yet. But because it has not occurred yet an observer cannot see it. So for every arbitrary snapshot of the lightning by the high-speed camera in standard time, the bolt of lightning flashing across a cloud will always be in the past as it unfolds to its final destination whereupon completion, the entire event will belong to the past.

This is a difficult concept to grasp because relative to an observer, the entire flash of lightning occurs so quickly, in a fraction of a second, that he cannot detect the distinction. The observer perceives the lightning as appearing in the present and once the event is completed, he perceives it as belonging to the past which is not what really happens. Let’s consider another example whereby a large amount of water in a river flows past a certain point like a bridge for example. This is a rather slow event but because different water molecules are flowing at different speeds depending on their depth and location in the river, there cannot be a single homogenous time to describe the passage of water under the bridge.

However we can make an approximated guess by placing a floating buoy on the surface at a specific distance before the bridge and measuring the time it takes for it to float past the bridge. So how does one interpret the passage of an event from the future directly to the past once it has occurred?

Once again one must consider the location and physical state of individual objects comprising the event relative to other objects or events which are not part of the first event. In other words to measure the passage of an event, one needs a point of reference, otherwise the information is meaningless.

This becomes obvious in the following example. An event which may have occurred and become a past event relative to observer A or object A located at one set of coordinates may not have occurred relative to observer B or object B located at another set of coordinates in 3-D space. Consider a train stopping at train stations. This is all the information we are given. The first observer is on board. Once the train has stopped at the first station then the event becomes part of the past but relative to the second observer located at the next station further up the tracks the event has not yet occurred therefore it's still in the future. Now let's consider a more complex effect of time.

In General Relativity, Albert Einstein discovered that the passage of time in strong gravitational fields is slower relative to the passage of time outside these fields. Experiments using two identical atomic clocks, one on the surface of Earth and the other in the sky on board a plane have confirmed this theory. The question is why do strong gravitational fields slow the passage of time relative to another frame of reference located outside this field? The answer lies in the reduced capacity for change that all objects experience within the gravitational field. A change in the physical state or set of coordinates of a given object to another physical state or set of coordinates requires energy which comes in many forms.

But the gravitational field of the Earth which pervades all objects within the field hinders, albeit in a minor way, the capacity for any given object to change its physical state or its coordinates relative to an identical object outside this frame of reference experiencing exactly the same changes. Since any given object experiences a gravitational force towards the center of the Earth, it would hypothetically require a greater amount of energy to overcome this attraction to change its physical state or set of coordinates by exactly the same amount as an identical object located outside this frame of reference.

We say “hypothetically” because in practice the extra energy needed to achieve this comparable amount of change is unavailable to the object on Earth. So the total amount of energy available in the process of change for a given object on Earth is actually imperceptibly lower than it is for the same object in orbit. This is why “universal time” slows down in strong gravitational fields.

With respect to notions of the possibility of travelling backwards in time one finds in the various semi-professional physics literature today, the previously mentioned definition of time clearly explains that this is not possible. Even if it were hypothetically possible to change the physical state and location of every single and infinite number of atoms in the universe to its former state and location in a given sequence of events, one would not be able to reverse the individual entropies of these atoms which are irreversible for eternity. However travelling forwards in time is certainly possible via time dilation effects within the context of the Theory of Special Relativity. This has already been proven to the satisfaction of the international scientific community.

This definition of time also helps one to understand why certain living creatures live longer than others for example. Why does a spider live longer than a fly or most other insects for that matter? The answer lies in the rate of change of the metabolism of the spider. Because it is motionless for most of its life, the metabolism or rate of change in the physical state of the spider is correspondingly much slower than an insect which expends a lot of energy flying around like a fly does for example.

As a general rule, when a given object expends more energy or experiences a greater amount of entropy relative to another object, then it will experience time (*change*) at a faster rate than this object. Conversely, when we freeze food for example, we are effectively slowing down its capacity to change, ie: we are slowing down its time. Lower temperatures mean that lower energy levels are available to change the physical state of the frozen food to another physical state than would otherwise be the case at ambient room temperature.

Is it possible to stop this process altogether, in other words to actually stop the passage of time relative to the food? Unfortunately because of the existence of zero point energy or what is known as "vacuum energy" which exists everywhere in our universe, it is not possible to stop the passage of time completely. However it is possible to slow it down considerably in one of two different ways which may somehow be connected.

Ideally one would need to isolate the food in a chamber which can be shielded from all types of radiation, electromagnetic, gravitational and nuclear and the temperature would have to be as close to absolute zero as possible. There would also need to be a perfect vacuum in the chamber containing the food. Another more controversial method of slowing down time is to maintain the freshness of the food by giving it the required energy levels it needs to maintain its fresh physical state. As unbelievable as it may seem, experiments have been undertaken with psychic subjects who can channel psychic energy to a leaf, for example, at a distance without touching it and maintained its healthy appearance for up to 60 days after it was cut from a plant. While control leaves all died and shriveled up within days to one week, leaves which received forty minutes of psychic energy every 24 hours remained alive for at least 60 days. Although mainstream science has not succeeded in explaining this phenomenon in strict scientific terms to date, numerous experiments conducted under professional conditions have nevertheless proven that it does indeed exist.

So what we have in effect is two opposing methods of slowing down time. The first consists of shielding the food from all types of energies to dramatically reduce the change in its overall physical state and the other consists of giving the food a good dose of psychic energy to achieve the same result. The question begs; why does psychic energy which is essentially based on human emotions of love, compassion and a sense of serenity have the same effect as reducing the presence of all the other types of energies that exist in the universe at a designated location?

WHAT IS TELEPATHY?

This is an intriguing question and although we don't know the answer, the latest scientific research has demonstrated that thoughts can physically affect matter at the quantum level and collective thought can indeed modify matter at our level of perception. We believe that it is just a question of time before psychic energy otherwise known as "Chi" by the Chinese or "Prana" by the Indians is explained and placed on a firm scientific basis. The process begins with thoughts which are generated by the brain's complex 3-D pattern of billions of electro-chemical pulses relayed along synapses between neurons. It is conceivable that this incredibly complex pattern of electro-chemical energy creates brain waveforms of the Fourier transform type which are transmitted over a neural-like network of zero point energy (ZPE). To use an analogy, waveforms would be transmitted over an infinite sea of zero point energy much like one falling domino triggers a succession of other dominoes falling over in a long chain.

The upright dominoes which all have a specific and identical amount of potential energy make it possible for the first domino's kinetic energy to be transferred across the entire chain to infinity in theory. Similarly, waveforms would be able to penetrate and literally pass through all types of matter since Neutrons, Protons and Electrons occupy a fraction of the space that compose the various molecules and elements in nature. These waveforms would almost certainly exist in the electromagnetic spectrum and the wavelengths would be rather long; probably longer than radio waves; since the energies involved are relatively weak. However it is probable that most complex forms of life generate these brain waveforms across the ZPE network which means there would most likely be interference and cancelations at node-like coordinates where intersecting waveforms would congregate. On the other hand it is also conceivable that there would be reinforcements if for example, a multitude of similar waveforms were transmitted simultaneously across the network from one particular location.

This would certainly explain the imprecise nature of information received by telepaths for example or the approximate nature of images of distant locations received by clairvoyants (*remote viewers*) for example. It may also explain why a collective of different animals seem to sense in advance an impending earthquake. It may also explain how certain psychics can predict future events.
